

Woodcarving Competition Change for Single Item in a Category

In past shows if there was only one entry in a category the piece was then reentered in a "miscellaneous" category. This yielded a wide variety of subjects for the judges to consider in one category. In a new judging set-up a single entry in a category will not be moved to a "miscellaneous" category. The singular carving will be judged on its own merit. If the judge team awards the carving a point total between 121 and 150 points it will receive a Blue ribbon, between 91 and 120 points a Red ribbon, between 61 and 90 points a white ribbon, between 31 and 60 points a Green ribbon. Any carving receiving less than 30 points will be awarded a certificate of competition.

There will still be a "miscellaneous" category for carvings that <u>fit no other category</u>. Each carving in this category will judged on its own merit and be awarded a ribbon based on the above point totals. Therefore, it would be possible that more than one blue ribbon could be awarded, or none, or that all entries receive a red or white ribbon.
